4.1 FULL COUNCIL **MOTIONS 2021** – NEXT ACTIONS

Executive discussed the work on the 2021 motions to date.

1.1 Year Level Funding Disparity

"THAT NTCOGSO request that the Department of Education review the disparity between the Middle and Senior School Year level weighting in the school resourcing model that creates a differential in funding between middle and senior schools, significantly in the favour of senior schools.

Further that the Department of Education increases the year level weighting of middle schools in line with senior schools so that middle schools can support the delivery of quality education and social and emotional development during early adolescence with the objective of achieving better engagement during middle school and more transitions supporting the completion of senior school."

Summary Note: Awaiting secondary education review being undertaken in 2023.

1.3 Access to School Counsellors

"THAT NTCOGSO requests the Department of Education to ensure access to School Counsellors for all remote and regional schools. At present when Mataranka School has requested Counsellor services, we have been told none are available and referred to Headspace. Headspace only operates for 12 years and older and thus, a vulnerable cohort are going without desperately needed services."

Barkly Regional Representative advised there is currently no School Counsellor in the Barkly region.

ACTION: PRESIDENT TO REQUEST THE DEPARTMENT OF EDUCATION PLACE COUNSELLORS IN THE BARKLY REGION AS A MATTER OF URGENCY.

1.4 Corporate SwAN Support for Regional and Remote Schools

"THAT NTCOGSO requests the Department of Education to provide more specific and tangible support to small regional and remote schools for Students with Additional Needs."

Summary Note: Awaiting the DoE review on developing a funding model for students with disability being undertaken in 2023.

1.5 Principal Reclassifications and School Budgets

"THAT NTCOGSO thanks DoE for recognising our Teaching Principals and the resulting pay increase under the current review process. That NTCOGSO monitors and advocates to DoE that this pay increase will not be funded from the school's budget."

Summary Note: NT COGSO considers this motion closed, however, maintains a watching brief.

1.6 Alice Springs Teacher Housing

"That NTCOGSO advocates to the Department of Education & Minister for Education Lauren Moss to secure teacher housing in Alice Springs to attract and retain interstate candidates to meet current teaching staff shortfalls in Alice Springs."

Sep 2022 DoE Update: "The Northern Territory Government acknowledges there are critical hard-to-fill roles, such as teachers, in urban locations where attraction is impacted by housing shortages.

To address this, in conjunction with Investment Territory, a development plan is underway for urban locations including Alice Springs and Katherine.

The Department of Education will commit to an appropriate number of dwellings with guaranteed head leases. This will improve availability of properties with the correct configuration of 2 and 3 bedrooms available to workforce on appointment to these urban locations."

Summary Note: NT COGSO considers this motion a watching brief.

1.7 Redirect SwAN Funding

"THAT NTCOGSO requests the Department of Education & Minister for Education Lauren Moss to review the current funding model for Students with Additional Needs (SwAN). Request that funds are distributed to schools based on their population of identified students with additional needs and/or educationally, socially or emotionally vulnerable students, so that funds are reaching students most in need."

Summary Note: Awaiting the DoE review on developing a funding model for students with disability being undertaken in 2023.

1.8 Swimming and Life Saving Program

"THAT NTCOGSO requests the Department of Education & Minister for Education Lauren Moss to implement a comprehensive Swimming and Life Saving program for students in Transition to Year 10, funded by the Northern Territory Government. Territorian students are falling significantly behind National benchmarks."

DEC22 NTCOGSO / CE Meeting: NTCOGSO and CE agreed to close the motion due to insufficient data and no response from Royal Lifesaving.

Summary Note: NT COGSO considers this motion closed.

MOTION CLOSED

1.9 Parent Engagement Policy and Guidelines

"THAT NTCOGSO requests the Department of Education to develop policy/guidelines to:

- 1. Improve parent engagement and inclusion in schools.
- 2. Improve community engagement in schools from preschool onwards."

SEP22 The Department of Education commenced implementation planning for the Education Engagement Strategy.

Goal 1 of the Strategy: Education is a partnership, aims to provide opportunities for families and education services to work together to ensure all children and young people get the best start to learning and they are supported and encouraged to continue their learning journey.

Summary note: Awaiting DoE policies from the consultations held Sep and Oct 2022.

1.10 School Road Safety

"THAT NTCOGSO advocate for the Department of Education to provide leadership and coordination to address traffic related safety issues around Territory schools. That the Department establish a working group, develop policy and provide adequate resources."

Summary note: March 2023 - Department of Education followed up with DIPL, who confirmed consultation will be undertaken and work is ongoing with the draft guidelines.

Awaiting response from DoE | DIPL – NT Road Safety Guidelines.

1.11 All Staffing Oncosts Funded Centrally

"THAT NTCOGSO request that the Northern Territory Government and Department of Education remove from school budgets, additional costs above salary associated with the accrual of long service, maternity/parental leave and extended personal leave and fund these from the departments centrally funded cost centre. Currently individual schools suffer the burden of paying the on-costs for this leave."

Summary note: Department of Education considers this motion closed.

NTCOGSO position is that all staff oncosts should be funded from the central cost code and not schools.

1.12 Funding for Water Audits

"THAT NTCOGSO request the Northern Territory Government commit to;

- 1. Funding for Water Audits (Water Use Health Check), including funding for the implementation of findings, for every government school in the NT with no reduction to fixed costs funding in the School Resourcing Model (SRM).
- 2. Resultant savings to be retained by schools with the same commitment from the Northern Territory Government as for the Solar in Schools program (no reduction to fixed costs funding for power)."

Summary note: NTCOGSO scheduling meeting with Power and Water to discuss programs.

1.13 Funding for Students with Additional needs

"THAT NTCOGSO request that the Department of Education target funding for students with additional needs so that students with a supplementary or QDTP classification under the NCCD also attract individual funding to support their individual needs."

Summary Note: Awaiting the review to develop a funding model for students with disability being undertaken in 2023.

2.1 School Road Safety Audit

"THAT NTCOGSO request the Department of Education complete Road Safety Audits for all Northern Territory Schools, with the audit report to inform improvements to a school road management campaign. Road Safety Audits are to be completed at peak periods and take into consideration student safety, car parking, road congestion, traffic/pedestrian management, bike and bus routes."

Summary Note: September 2022 Update from Department of Education: As the majority of NT government schools are located on roads that are not managed by the NT Government, schools are advised to engage their local council to get assistance with solutions to road issues surrounding their schools e.g. improved signage and parking etc. Communications have been developed for principals, school representative bodies (councils/boards) and NT COGSO which includes maps of NT Government owned roads and contacts for local councils responsible for non-government roads.

"Schools can liaise with the road owner in order to organise a road safety audit."

The Department advises this motion closed.

2.2 Resourcing for Female-to-Female Aggression

"THAT NTCOGSO request that the Department of Education and Territory Families provide expert in-kind support (and if necessary, seek external expertise) and co-fund appropriate resources for Darwin Middle School to codesign, pilot and evaluate, an evidence-informed school-based framework, policy and corresponding curriculum to address increasing rates of female-to-female aggression and violence between students. Additionally, with a view to expand to all government schools across the Northern Territory".

Summary Note: The Department considers the motion closed.

NTCOGSO in contact with Darwin Middle School Board to discuss.

2.3 School Based Police Program Publications

"THAT NTCOGSO request the Department of Education and NT Police jointly develop a publication for dissemination to NT Government school staff, parents, families and students which reflects the operation of the NT School Based Police (SBP) program including (but not limited to):

- The NT SBP program's background,
- Aims, objectives, and rationale for the SBP program,
- Included activities and responsibilities,
- Excluded activities and responsibilities,
- Expected outcomes, methods to measure outcomes and how outcomes will be communicated to the public
- Contact details for enquiries, feedback, and complaints in relation to the SBP program,
- Clearly articulated role boundaries and responsibilities, particularly between SBP, NT Government schools and NT Police more broadly. It is requested that the publication provide clarity about processes, role boundaries, responsibilities, and the protocols for communication between NT Government schools, SBP, broader NT Police and parents/carers, in relation to incidents or potential offences involving students at school, such as assault."

September 2022: Department of Education advised "Version 1.0 School Based Police Program Operational Guidelines was approved by the Police in Schools Management Committee in May 2022 and made available to the 13 participating schools through the School Based Police Program Consultative Group at the beginning of June 2022.

The Management Committee asked that a review of the Guidelines commence in June 2023 with the aim of releasing an update prior to the commencement of the 2024 school year.

NT COGSO were included in the development consultation process through the School Based Police Program Consultative Group. NT COGSO did not provide any specific feedback. The Operational Guidelines respond to the recommendations in the 2019 School Based Police Program Review and address the program elements requested by NT COGSO."

October 2022: Department of Education advised "Audience-specific information aimed at parents and students in relation to broader NT Police activities in NT Government Schools was published on the department's external facing website 5 October 2022."

Summary Note: NTCOGSO is awaiting the commencement of the review of the School Based Police Program Operational Guidelines in June 2023.

2.5 'Effective Enrolment' terminology

"THAT NTCOGSO request the Minister for Education change the terminology of 'Effective Enrolment' when calculating school budget funding based on student numbers. The funding calculation of student numbers for school budgets is based on attendance not enrolment and replacement terminology should reflect the word attendance, until funding is actually based on enrolment."

Summary Note: Awaiting the review to develop a funding model based on enrolment.

Executive Officer sought update on 15 March from the Department as they had advised in October 2022 that "the recommendations were expected to be released end of 2022."

2.6 Education Infrastructure Budget

"THAT NTCOGSO requests the Northern Territory Government commit to a significant increase of at least 60% in the 2021/2022 Education Infrastructure Budget effective year on year from 2022-2023 until every government school meets current building standards including every general learning area and facilities."

Summary Note: Department advised this motion is considered closed.

NTCOGSO to maintain advocacy with the NTG.

4.2 FULL COUNCIL MOTIONS 2022 - NEXT ACTIONS

Executive discussed the work on the 2022 motions to date and agreed on the following actions:

Motion 1.1/2022 - Larrakeyah Preschool Stage 1

"THAT NTCOGSO advocate to the Minister for Education and the Department of Education for Stage 1 of the Larrakeyah Master Plan to be constructed in the immediate future to enable all children that reside in the Primary Catchment Area for the Larrakeyah Primary School to be able to attend their local Pre School."

Summary Note: Executive determined this motion closed as the Department of Education is in direct discussion with the school, the school rep body, particularly, the Chair.

Motion 1.2/2022 - Department of Education – Communications on Corporate staff and programs

"THAT NTCOGSO requests from the Department of Education (DoE) and Minister for Education, Eva Lawler, a commitment to communicate online via a live website to all Principals and School Representative Bodies, the designated DoE staff contacts for all roles and responsibilities of DoE corporate and associated programs."

Summary Note: 28 February, Executive formally wrote to Chief Executive and Minister for Education.

Awaiting response from Chief Executive, Department of Education.

Motion 2.1/2022 - Remote Teacher Housing - Review of Domestic Furniture Standard

"THAT NTCOGSO advocate for a review of the Domestic Furniture Standard for DoE Government Employee Housing (GEH) for remote teacher housing by the Department of Education to support the purchase of adequate furnishings for the wellbeing and safety of remote staff. The Policy and Guidelines must include a review cycle to reflect current market values".

Summary Note: 28 February, Executive formally wrote to President of AEUNT requesting collaboration as this motion is more suited to the work of the AEU.

Awaiting response from AEUNT

Motion 2.2/2022 - Information for Families on Electronic Smoking and e-cigarettes

"THAT NTCOGSO advocate that the Northern Territory Government provide information to families and the community on the dangers of electronic smoking and e-cigarettes (vaping). That the Department of Education corporate staff provide support to schools in managing the use of e-cigarettes by students at school."

Summary Note: Ongoing and frequent discussions on this motion is occurring.

Motion 2.3/2022 - Provision of Financial Governance Training

"THAT NTCOGSO request the Department have available, sufficient and trained staff to provide Financial Governance training across all regions.

- Contexualised (suitable for all members)
- Ongoing (based on need)
- On the ground (in the school community)
- o Delivered to school representative body members, with their Principal and Business Manager. This is in addition to the "mandatory training for all school leaders (principals, assistant principals, business managers), those with delegation, and school representative bodies on declaring and managing conflicts of interest" as recommended by the NT Independent Commission Against Corruption (ICAC)."

Summary Note: Meeting scheduled for 24 March with Department of Education, Susan Bowden.

Motion 2.4/2022 - NTCOGSO Operational Funding Agreement

"THAT the Northern Territory Government through its agency, provide additional appropriate Operational funding to NTCOGSO for the period of 2024 to 2029 to enable the staffing of two (2) full-time positions in addition to the running costs of an office and operational expenditure. That the

Northern Territory Government through its agency, commence negotiations with NTCOGSO early in Semester 2, 2023.

Summary Note: Commencing start of term 3, 2023.

Motion 2.5/2022 - Ministerial Guidelines - Amend Teacher Member Definition

"THAT NTCOGSO requests the DoE CE publish guidelines to amend the 'teacher member' in all School Representative Body Guidelines to state a classroom teacher includes an Assistant Teacher who teaches at the school. Further, the Guidelines should also include that a teacher member must not be an Assistant Principal. Recommendation: "the school representative body membership must include at least one assistant teacher or teacher (other than the principal or assistant principal) who teaches at the school or preschool."

Summary Note: Meeting scheduled with Tanya Salabay | Director School Review and Operational Policy | Quality Standards and Regulation and NTCOGSO Executive Officer and Project Manager. Meeting to discuss AGM supports, School Rep Body Guidelines, and legislative review.

Motion 2.6/2022 - Taminmin College - Business Plan Development

"THAT NTCOGSO request the Department of Education 'provide Central staffing resources' to complete a 'business plan' and 'capital works application' for new VET infrastructure, fit out and resources to 'meet and' deliver the VET course needs in the community."

Summary Note: Office of the Chief Executive advised discussions to be undertaken with the School Board 2023.

Motion 2.7/2022 – Amendments to the Department of Education Complaints Management Policy and Guidelines

"THAT NTCOGSO advocate to the Department of Education to change their current complaints policy, processes, and practices to provide better support to parents. This is to include:

- a. a monthly report provided to NTCOGSO of the number of parent complaints, by region, including the number of parents who have children experiencing vulnerability.
