3. REPORTS

3.1 PRESIDENT REPORT

President presented a written report and noted that since the last Executive meeting the advocacy focus has been on School Counselling which has been all encompassing for the last several weeks. This included media engagements and discussion with schools, families as well as ex-school counsellors sharing their concerns and experiences.

Other main advocacy focus has been on youth electronic smoking and pleased to see the national response on this issue.

Since the Executive teleconference held Monday 29 May, the School Engagement and Advisory Group (SEAG) quarterly meeting was held Wednesday 31 May which included a presentation on Student Wellbeing and Inclusion Programs and Services (SWIPS). Immediately following the SEAG meeting, President and Executive Officer met with Aderyn Chatterton, Director, SWIPS and outlined concerns regarding retaining a School Based Counselling service.

NTCOGSO will continue to work with the Director of SWIPS and will be seeking the evidence used to determine the proposed model. NTCOGSO will also be looking at the outcome of this model

in Victoria as anecdotally they may have moved away from this model type of multi-disciplinary and triage.

Requiring consent from a parent for students to access Counselling services will remain an ongoing conversation between NTCOGSO and the department. We must ensure that measures put in place do not deter our youth seeking from seeking support from a counsellor.

Measures such as:

- o requiring parent permission if under the age of 16
- o completion of a formal request
- o request being considered by staff in the Mitchell Centre

We remain concerned regarding decisions relating to Student Wellbeing and Inclusion being made by public servants who are not clinicians with relevant expertise.

Executive Members noted the distribution of school facing positions in the regional multidisciplinary teams across regions based on student numbers and are seeking for allocations to be based on student need in regions, not student numbers.

Given the departments 2018 'STUDY OF THE SCHOOL COUNSELLING SERVICE IN NORTHERN TERRITORY GOVERNMENT SCHOOLS' which recommended the provision of school-based professional wellbeing, mental health and education support for all Northern Territory students, members requested information on the evidence relied upon by the department for service delivery changes.

Treasurer noted all reporting is up to date with the ATO. Maintaining a close eye on the budget with four (4) weeks to go until end of financial year – both training and operational at maximum budget expenditure to date.

The Department did not pay the GST component in the last two Governance Training funded amounts (Nov 22 and Apr 23). Executive Officer and the Bookkeeper have followed up several times. Executive Officer will request the GST components be paid prior to end of financial year.

OneIT service agreement is increasing by 7.5% which is not feasible on our operational budget. Executive Officer will explore other IT providers.

The policy has been renewed at no cost at this stage to 30 June.

Department has volunteers' insurance which covers SRB members.

Negotiated to move from a school product to a Business Package. This greatly reduced excesses from the previous 10k to 25k, down to \$500 for all claims. Also resulted in a reduced premium. NTCOGSO's assets level insured was increased from \$150k to \$160k. This asset figure is current to date, accurate and reflected in the asset register.
