Larrakeyah Chair advised members that the DoE had determined that a Larrakeyah pre-school will not be prioritised for 2023. Larrakeyah Board have funded an additional Teacher Assistant to increase the capacity of the preschool from 22 students to 27 students commencing January 2023 (ACECQA advise 29 students is capacity, however once the number of students exceeds 27 industrial considerations require a second fully qualified early childhood teacher to be employed). Even with enrolments restricted to children residing within the school's primary catchment all of these new places have already been filled. The Board's investigations suggest that Parap Primary school who have a commitment for an additional pre school building, are running at approximately 1/3 capacity.
