4.1 Larapinta Primary School – Virtual Link

"that NT COGSO organise a virtual invite to the COGSO AGM to facilitate broader, more cost-effective participation from Alice Springs, remote communities, Katherine etc."

5 LATE MOTIONS

5.1 Moulden Park Primary School – Security Audits of School Facilities

"that NT COGSO support a request to NT Government to undertake security audits of all school facilities to ascertain the need for updated and improved security measures to combat increasing vandalism and break ins of schools. Measures must be supported by NT Government via new works rather than individual school budgets."

5.2 Moulden Park Primary School – Central Funding and Provision of Onsite Primary School Counsellors

"that NT COGSO support a request to have school counsellors on site at all primary schools to enable early support to students, families and staff in developing positive mental health through trauma informed approaches/practices."

Following discussion on the amendment, the amendment was put and carried unanimously.

The motion now reads:

"that NT COGSO strongly campaign NT Government, the Department of Education, and Minister to provide and fund centrally school counsellors onsite at all primary schools to enable early support to students, families and staff in developing positive mental health through trauma informed approaches/practices."

5.3 Moulden Park Primary School – Provision of Additional Support Staff in Early Years Primary

"that NT COGSO request Department of Education (DoE) to provide extra support staff in early year's primary schools to assist teachers with behavioural management through the cementing of Social and Emotional Learning and Restorative and Reflective practices. This we feel will continue to improve behavioural pathways into middle and secondary schooling as students will have the tools they need and it will reduce the stress of behaviour management on all teachers."

5.6 Casuarina Senior College – Enrolment Data & DoE Policies

"that NT COGSO clarify the Northern Territory Department of Education's policy with regard to the enrolment of students residing outside designated priority enrolment areas, with particular regard to a school increasing its enrolment capacity when existing places are available at a student's local school. The Casuarina Senior College Board asks that COGSO and the department work strategically with schools to ensure priority enrolment area policies are followed. This strategic approach will ensure, policies, procedures and plans are in place to allow all students the best of education without residualizing other public schools."
