10.1. Primary School Transition Policy

"THAT NTCOGSO advocate for a Primary School Transition Policy and Guidelines to be developed and implemented by the Department of Education to support students and families during the important transition from primary to middle school.

The Primary School Transition Policy and Guidelines must incorporate remote students and families, including but not limited to additional support by the department working with families in collaboration."

10.2. ELDERS Program expansion into Primary Schools

"THAT NTCOGSO collaborate with the Smith Family to expand the ELDERS program into additional Primary Schools."

10.3. Security Fencing at Yuendumu School

"THAT NTCOGO request

- 1. That the Department of Education urgently action the construction of security fencing at Yuendumu School to ensure the safety of school students, staff and property.
- 2. That the Department of Education conduct a security audit of all school premises to identify potential points of entry so that these can be addressed, in consultation with school leadership.
- 3. That all Department of Education staff housing undergo a full security audit to identify potential risk.
- 4. That all Department of Education staff housing be fitted with alarm systems to ensure personal and property safety and deter potential intruders.
- That the Department of Education urgently address concerns raised and take appropriate
 measures to rectify issues in regard to staff housing fencing which has resulted in housing
 becoming a vulnerable target to theft."

10.4. New Principal Training and Support

"THAT NT COGSO request the Department of Education to provide immediate and ongoing support, mentoring and training for Principals. Specifically, where recruitment is from a contextually different educational setting such as from a primary school to a high school."

10.5. Katherine High School Special Request

"THAT NT COGSO request the Department of Education to apply special circumstances to Katherine High School and waiver the projected deficit in 2019 resulting from a lack of mentoring and support by the Department, in accordance with previous verbal assurance made by the Chief Executive in a meeting with the Principal and School Council Representatives."

"THAT NTCOGSO advocate for increased support from the Department of Education for students and families during the important transition from primary to middle school, with a particular emphasis on vulnerable students at risk of disengaging at this point in their education.

Further, THAT NTCOGSO request the Department of Education to provide prior to the end of term 4 2019:

- The number of Indigenous year 6 students, as at week 4, term 1 by school and by gender for 2017, 2018 and 2019
- The number of Indigenous year 7 students, as at week 4, term 1 by school and by gender for 2018 and 2019."

THAT a report with recommendations be prepared and presented to NT COGSO by 30 June 2020."

"THAT NTCOGSO request the Minister for Education and the Chief Executive of the Department of Education to immediately follow up, prior to the end of term 4 2019, Yuendumu School Council's urgent request to have the colourbond fencing around staff housing removed, as a matter of urgency and replaced with the same fencing that was originally in place, and consult with the Yuendumu School Council and all staff on timeframes and action. In addition to addressing the issues of asbestos in School Buildings and Staff Housing."

What steps is the Department of Education taking for recruitment and retention to these positions."

11.4. Upgrade to Student Management System

"THAT NTCOGSO advocate for the redevelopment or implementation of a new student management system by the Department of Education to allow more direct and up to date information for Students and Parents. This access should be available online and on demand.

Alternatively, that the Department of Education make the current student management system compatible with current online learning tools. By compatible we request that information on students and assessment need only be entered once and accessible by other relevant systems."

11.5. School Based Police Program expansion in Primary Schools

"THAT NTCOGSO advocate to the Northern Territory Government and the new Police Commissioner for an expansion of the School Based Policing program to include additional School Based Police Officers for our primary schools in 2020.

The number of School Based Police Officers must meet the needs of all government primary and secondary school communities, regardless of geographic context; must have regular contact and opportunity to develop a positive/familiar relationship with School-Based Police Officers.

The societal benefit will be immense, we therefore request an expansion of the program to include dedicated, specialist trained officers who are fully resourced with cars and technology, in primary school clusters.

The additional Primary School Based Police Officers must not be to the detriment or reduction of the Middle School Based Police Officers, rather in addition to."

11.6. Community Benefit Fund Priority Change

"THAT NTCOGSO request the Attorney General change the priorities of the Community Benefit Fund from Infrastructure to addressing the mental health and wellbeing of Territorians; in recognition that the fund is generated through a 10% levy applied to electronic gaming machine losses, which have significant negative social consequences as a direct result of problem gambling."
